

Anne Couvent's Ascending Armorial Lineages: References

The following sources were used to document both the genealogical and heraldic details for Anne Couvent's ascending armorial lineages. To assist the reader some clarifying notes are added as necessary. Many of these older works are now available for free to download online.

However, the author is to be given credit for citing his sources and for making corrections when notified of mistakes. He has also been helpful in reviewing earlier drafts of these armorial lineages and pointing out some mistakes I made and subsequently corrected.
